All vendors must collect and remove all of their unsold goods and materials associated with the display thereof from the gallery on the breakdown day. Any unsold works or materials left behind after the pickup time cutoff shall be considered abandoned, and shall become the property of Organizer. Organizer, in its sole discretion, may dispose of said property in any manner it deems Proper. Vendor is responsible for all sales and sales issues during the exhibition hours, including relevant business permits, sales tax collection, making change, accepting checks, and credit card processing.

ASSUMPTION OF RISK

Vendor expressly assumes all risks associated with, resulting from or arising in connection with Artist's participation or presence at the show, specifically including, but not limited to, all risks of theft, loss, harm, damage or injury to the person including death, property, business or profits of Vendor, whether caused by negligence, intentional act, accident, act of God or otherwise. Vendor has sole responsibility for its property and/or exhibits or any theft, damage or other loss to such property (whether or not stored in any courtesy storage area, loading dock or bay, including but not limited to any subrogation claim by its insurer).
